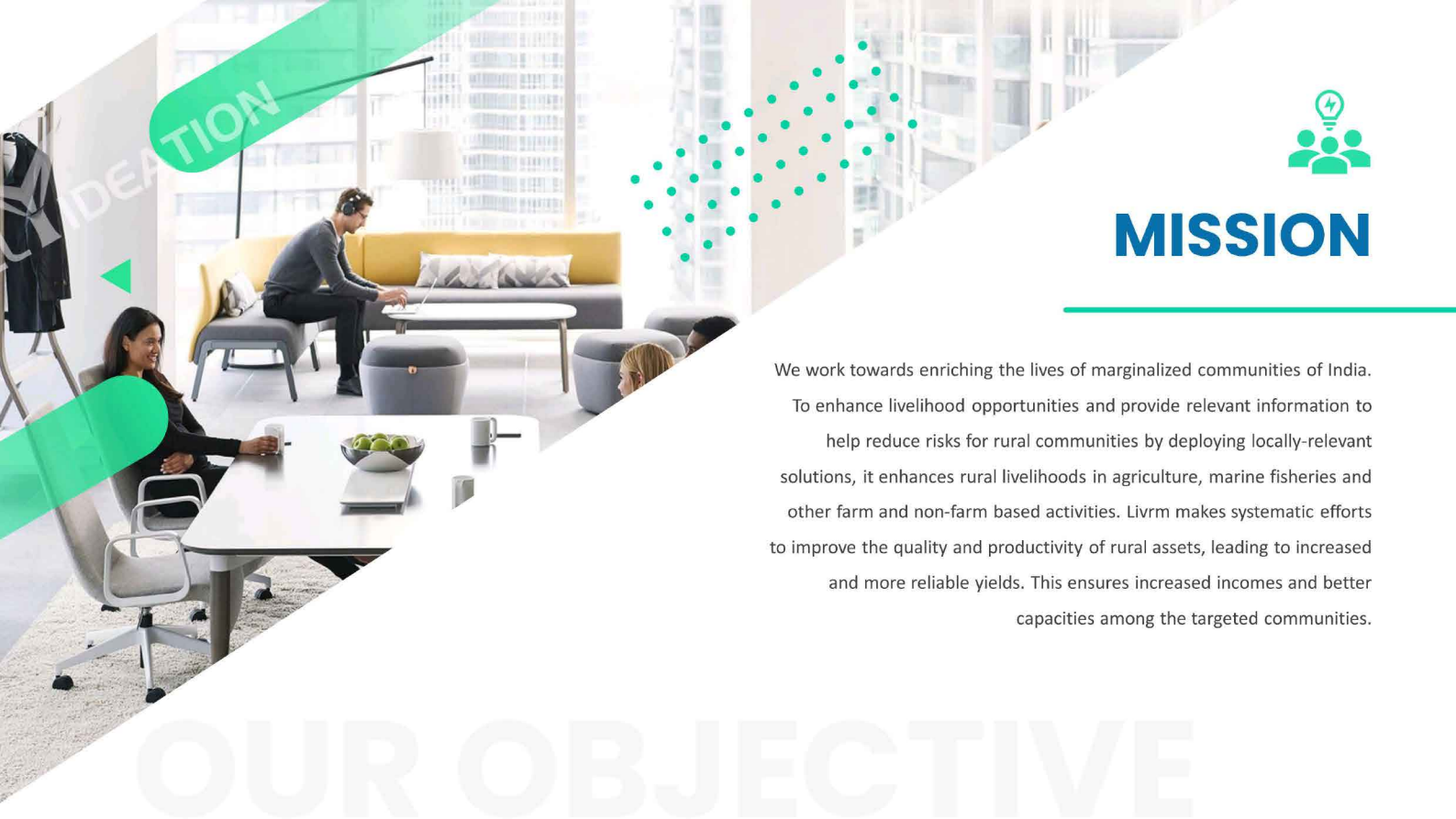


## VISION

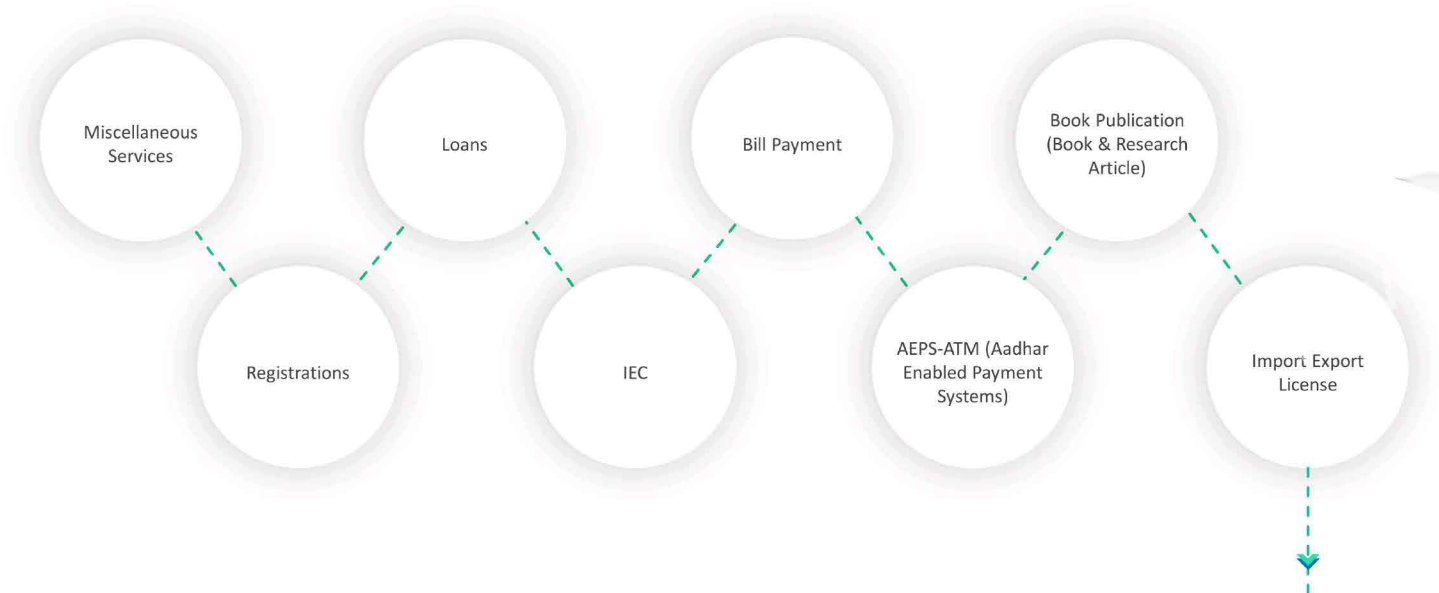

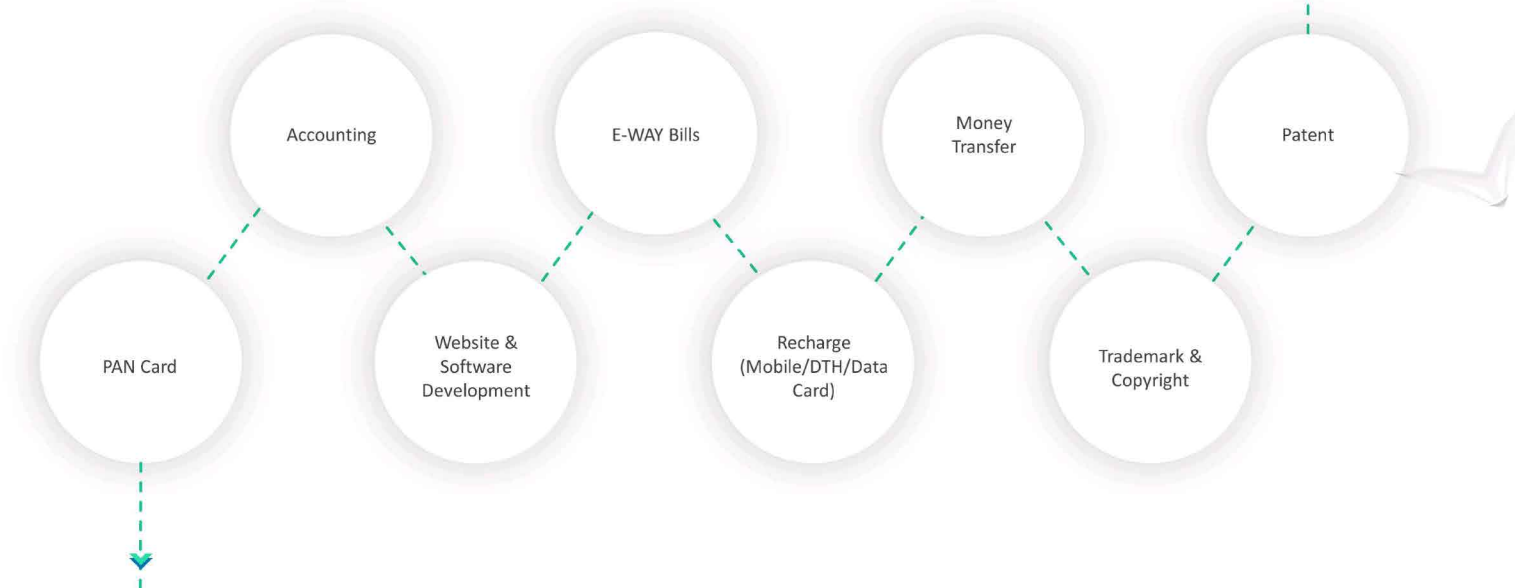
